Job Closing Checklist

When using the Job Management module, there are many options that may be used for different types of Jobs. The options used depend on each company's internal policies and procedures.

When reviewing completed Jobs and preparing to close, it is a good practice to have a formal checklist of items to be verified prior to closing the Job to insure all costs, income, documentation, etc. have been correctly posted to the Job. You may have one checklist for simple installations and another for more complex types of jobs. Implementing the use of a Job Closing Checklist reinforces company policies and procedures, since people are people and may forget to do things that are important to the company process.

Note: You may want to consider using some of the Job Custom Fields as an electronic Job Closing Checklist.






