About This Release

These release notes document the application corrections made in both 5.7.41 and 5.7.42. **Customers updating from a version prior to 5.7.40 should read the release notes from that version as important changes were made in that release.**

Application Corrections

Accounts Payable

Bills - Customers Using GST Tax

Reported Issue: AP bills were erroneously being marked out of balance due to a GST decimal point and rounding issue. This issue has been corrected.

Reported Issue: AP bills were being marked as paid at the time that they were entered due to a GST decimal point and rounding issue. This issue has been corrected.

Reported Issue: AP expense line only bills were not automatically calculating GST when a branch was not selected on the expense line. This issue has been corrected.

Vendor Credits

Reported Issue: When a vendor credit was saved all fields were visible. When the user exited the credit and later went back to view it, the details could not be displayed. This issue has been corrected.

Accounts Receivable

Credit Requests

Reported Issue: Customers received the error message "The approved amount does not equal the requested amount" when creating credit requests. This issue has been corrected.

Reports

Income Statement By Category

Reported Issue: This issue affected customers that had more than one company database. The Income Statement By Category Report was reporting figures from the last SedonaOffice company opened instead of the figures from the current company for which the income statement was requested. This issue has been corrected.
